**Resolution:** Purchase and display a banner on the church exterior in support of Black Lives. Jack read the resolution that passed at the last congregational meeting. And discussed tragic recent events, specifically how they represent systemic racism. The Black Lives Matter to Unitarian Universalists committee will submit designs.

**Presentation of Budget:** Presented by Carolyn Feldt, Finance Director. Carolyn thanked the Finance Committee, the Board and Reverend Erik all the hard work that went into creating a significantly reduced budget due to the impact of COVID 19. Carolyn reviewed the budget. Revenue down is \$25,000 this year, 25% is loss of fundraising and other events. Despite the decrease, we are funding 3 new priorities. Professional streaming services added \$4500 to budget. Second, give a small increase in the minister's compensation. Erik has had no raise since he started at Bradford. We are belowUUA guidelines in minister compensation. Our goal is to rectify this gap in four years. The third priority is to hire Rev. Dr. Monica Cummings as

a part time assistant minister. Erik discussed the restructuring of roles within the church due to vacancies in the secretarial and Religious Education positions as well as changes necessitated by COVID 19. Finance has cancelled the cleaning contract. Sarah Kirby asked if congregant's could clean to reduce costs. Mary Kay Schleiter was concerned that membership went down and asked many members we currently have compared to a year ago. We have 100 members, which is the highest number in many years.
